The Clubs policy of blood tests being taken when there is an accident on the trails was being questioned. Mike Kelso asks that clarification of the circumstances that warrant when a blood test is necessary be made clear by the executive board. It was also discussed that all trail officials be made aware of what procedures they need to take to make sure the club is covered in case of accident (i.e. make notes, are pictures needed, should they get witnesses names, blood test, etc.). If these are not the club rule, then let officials know.

The Zipline posting the road at the top of their line is again (or still) a problem. David Adams was on Hells Revenge when he was confronted by one of the Zipline employees on an ATV saying it was private property. David talked with Sheriff, Steve White, who says it is still supposed to be a public road, but now must be dealt with by the county attorney.

Representative Bob Bishop has presented Bill #5204 to approve a public day use fee on any public lands. This could be detrimental to all users.

Hey Joe Canyon trail may be lost Doug McElhaney reported, as a member of the Grand County committee putting together a proposal for Bob Bishop to limit the acreage designated as a monument. The committee includes members from the oil/gas, nature conservancy, bikers, motor cycles, ATVs and four wheelers, and it has been discussed that Hey Joe may be lost to the monument, one reason being there is a WSA across the river. The dense tamarisk made yearly brush clearing a necessity but the trail may eventually degrade to the point of impasse with the sides sloughing off more all the time. Ber Knight actually reported some shovel work needed to be done on numerous washouts to make it passable now but the tammies have been cleared by the beetles. Doug said it is one of the few trails with the markings of Dennis Julians on it, so if we want to press it we might be able to get it into the historical register to save it.

Labor Day Campout was a success this year. Using the website to e-mail notices to mailing list participants instead of USPO mailing of a flyer helped to alleviate some of the expense. A breakfast of cereal was donated by James Graves and Ed & Janice Helmick of AYJ Books in Provo donated dinner. The Campout is enjoyed by fewer participants than EJS but seems more relaxed as the trails are smaller. Thanks to all who worked hard to make this a great event again this year.

9 Mile Canyon in Price is being reviewed by the BLM for Resource Management. To comment on this go to the BLM website, Price field office.
